From the Desk of the Division Commander

It is that time of year again, elections!! With all of the changes in the past 2 years, it is imperative that the screening committees give their due diligence in verifying eligibility for each candidate. As you should know by now, the requirements for leadership have been updated. Those wanting to run for a leadership position must have completed the Administrative Procedures Course, (APC) and either the Auxiliary Flotilla Leadership Course (AFLC) or the Auxiliary Leadership

Management School (**AUXLAMS**). The <u>AFLC</u> test can be completed online, open-book, but does have a time limit. The APC course is based solely on the Auxiliary Manual (**AUXMAN**) and is also an open book exam with a time limit.

With the latest changes that took place during the National Training Summit, we now have <u>limits for VCDR and VFC in place that will take place immediately.</u> First, criteria for serving as either a Division Vice Commander (**VCDR**) or a Vice Flotilla Commander (**VFC**) has been changed, effective immediately. First approved policy change:

- 1. Policy Change: Unlimited terms for elected Vice Flotilla Commanders (VFCs) and Vice Division Commanders (VCDRs) have been <u>removed</u> to align with the term limits of Flotilla Commanders (FCs) and Division Commanders (DCDRs).
- An important amendment to our leadership policies has been approved. This
 amendment removes the provision that allowed unlimited terms for elected Vice Flotilla
 Commanders (VFCs) and Vice Division Commanders (VCDRs). This change brings their
 term limits into alignment with those already in place for Flotilla Commanders (FCs) and
 Division Commanders (DCDRs).

- The decision stems from concerns that unlimited terms were unintentionally creating barriers to leadership development. In many cases, long-serving VFCs and VCDRs have remained in their positions for years without advancing, which has discouraged new members from stepping into these critical roles. Since these vice positions are designed to serve as developmental steppingstones—opportunities for emerging leaders to gain experience under the mentorship of FCs and DCDRs—the unlimited term policy was undermining the intended progression of leadership within the Auxiliary.
- Under the new rules, VFCs may now serve a maximum of two consecutive one-year terms, after which they must take a one-year break before becoming eligible again. This cycle may be repeated indefinitely. For DCDRs and VCDRs, the limits are slightly different: they may serve a maximum of four terms in total, with no more than two terms being consecutive. If a member transfers to a different Division, a new term cycle begins. Additionally, any leader who has completed the maximum service in one of these offices may once again run for election after a four-year absence, at which point eligibility resets for another full four-term cycle.
- This amendment was endorsed by the National Board and formally approved by the Chief Director today. It is now effective immediately.

So, everyone needs to check to ensure we are in compliance with the new policy for this election.

The second approved policy change has to do with the Auxiliary Recruiting Award:

- 2. Revision of the Auxiliary Recruiting Service Award
- The criteria for the Auxiliary Recruiting Service Award have been revised to make it
 more attainable and to encourage greater participation in recruiting efforts. Previously,
 Auxiliarists were required to recruit seven new members in a single year to qualify for
 the award. Effective immediately, the threshold has been reduced to three new
 members per calendar year.
- This change comes in response to the challenges the organization faces in sustaining and growing its membership. The Auxiliary has been experiencing an average annual loss of 2.5 percent, and most districts continue to lose more members than they bring in. Under the old standard, very few members were able to achieve the award, which limited its impact. By lowering the requirement, the Auxiliary aims to spark more interest in recruiting and ultimately strengthen membership across the organization.

- To count toward the award, at least three of the recruited members must achieve either IQ or BQ status within one year of their Base Enrollment Date (BED). For example, if a new member has a BED of September 20, 2024, but does not transition to IQ or BQ until March 15, 2025, they will still count toward the 2024 award. However, if they do not reach IQ or BQ by September 19, 2025, they will no longer be eligible to count. Auxiliarists seeking recognition must provide their Flotilla Commander with documentation from AUXDATA II to validate their recruiting accomplishments. Only one award may be earned per calendar year.
- This revision was approved by the National Board and concurred by the Chief
 Director. The change applies retroactively to cover recruiting activity that began in 2024,
 with the first awards under the new criteria to be presented in 2025.

The third and final approved policy change has to do with our CORE Training requirements:

- 3. Reactivation of CRA and SAPRR Training for AUXCT Requirements
- The Civil Rights Awareness (**CRA**) and Sexual Assault Prevention, Response, and Recovery (**SAPRR**) courses, both required Auxiliary Core Training (**AUXCT**), have been updated and are now available again in the Auxiliary Online Classroom (Moodle).
- Auxiliarists who still need to complete these courses must do so by December 31,
 2025 in order to meet AUXCT requirements and avoid being placed in REYR status.
- These courses are available at: https://classroom2.cgaux.org/moodle/

Please check with your record in AUXDATA or get with your member training officer or your IS officer to check if this applies to you.

Now for those of you who did not attend our District Training Conference, (**D-TRAIN**), you missed an opportunity to train and enjoy fellowship with your fellow Southeast District shipmates. There were a variety of classes available and many members were able to complete their PQS tasks and become certified in various competencies. District elections also took place for the three District Captains. **DCAPT-N** will be **Sean Flynn** from Division 14. **DCAPT-E** remains unchanged with **Jeff Barnes**. The new **DCAPT-W** will be **Karen Miller** from Division 11. Elected officers will assume their position on January 1,2026.

01 OCT 2025 FM: CHDIRAUX TO: ALAUX ALAUX 039/25

Subj: AUXILIARY OPERATIONS DURING A LAPSE IN APPROPRIATIONS

1. The federal government shutdown has resulted in the absence of an enacted appropriation or continuing resolution for the Department of Homeland Security. As a result, the Coast Guard must implement an orderly suspension of certain operations and activities. Guidance has been provided to Coast Guard elements regarding operations during this period. The Coast

Guard will continue legally authorized operations necessary for the safety of human life, protection of property, or national security, including emerging contingency operations.

- 2. Auxiliary operational activities may only be performed if specifically ordered by a Coast Guard Order Issuing Authority (**OIA**) in direct support of an excepted function. These functions are primarily limited to urgent search and rescue (**SAR**), aids to navigation (**ATON**) outages, and security threats. Auxiliary volunteer activities, such as Flotilla/Division meetings, recreational boating safety outreach, and public education, may proceed in accordance with the Auxiliary Manual, provided there is no obligation of Coast Guard funds. Emphasis must be placed on ensuring that Auxiliary operational activities are specifically ordered by a Coast Guard OIA and that other volunteer activities are conducted only if they do not require Coast Guard funding.
- 3. Liability coverage remains unaffected during the shutdown for Auxiliary activities, including meetings, all-hands gatherings, vessel exams, public affairs, culinary, chaplain, and administrative support functions.
- 4. Auxiliary augmentation of Coast Guard units remains authorized for non-operational missions, activities, and functions, as long as they do not incur Coast Guard appropriated fund expenditures. Funded orders cannot be issued during this time, but non-funded orders may be issued to ensure liability coverage.
- 5. For any questions, please refer to the Chain of Leadership and Management.
- 6. Internet release is authorized.

Let's keep busy, only operations are on hold for now. Remember, the members who are doing the tasks are what makes us all stand tall!

Vessel Examinations

1. Accomplishments in Recruiting and Retention:

 Four new members have qualified as Vessel Examiners. An additional member will qualify once he completes Introduction to Risk Management. After the last trainee finishes, we will be back up to 17 Vessel Examiners.

2. Program/Department Activities, Events, Projects, and Performance:

• In this quarter, we held two vessel exam events. One event at a local boat ramp where we completed 20 exams. We also had the Lake Allatoona Poker Run on August 9th involving seven vessel examiners and one trainee. We also had three guests from the Power Squadron, including their Commander and two trainees. All three of the trainees completed their required exams to become certified as vessel examiners. We conducted 29 vessel exams, plus 17 paddle craft exams, for a total of 46 exams for the day. The United States Coast Guard Auxiliary Flotilla 25 and Lake Hartwell Partners for Clean Water worked together to improve the environment through cleaning up Lake Hartwell. On September 27th, 2025, eighteen (18) USCG Auxiliary members and officers joined The Fall 2025 Splash Away the Trash Clean-up Event. During the event Flotilla 25 Auxiliarists invested over 108 hours in removing over 22 bags of trash,



two tires, disintegrating Styrofoam dock floats, and several plastic artifacts.

To accommodate the event, the Flotilla moved the monthly meeting from Portman Marina in Anderson, SC, to the home of a member who lives in Hart County, GA. The monthly meeting was held after the clean-up event.

Auxiliary member team efforts hope to ensure cleaner water, air, and soil in support of building a healthier community. In addition to clean up efforts, the Auxiliary's ongoing mission is Recreational Boater Safety (**RBS**). Through our mission we provide Vessel Safety Checks, Business Partnerships, and Boater Safety information, as well as a Boater Safety Education Course that is required to operate a boat on the lake for persons born after January 1, 1998. All activities including education are provided by United States Coast Guard certified member instructor teams.



For those members not familiar with what is handled by the Auxiliary National Supply Center (ANSC), the catalog is on the national web site (www.cgaux.org) under the "Auxiliary Members" tab and the sub-tab is

"Auxiliary Manuals". When that page comes up, it is the green notebook on the extreme right. If there are any questions about what you can or cannot get, please contact me.

For other items, such as uniforms and accessories, there is the store on the Coast Guard Auxiliary Association's web site (www.cgaux.org — or via the direct link on the Auxiliary web site under the next to last tab on the right). If you are looking for small items like ribbon bars or some uniform items that might be in your Flotilla store (if applicable), check with your FSO-MA officer first to see that is the case before placing an order on the web site. This can probably save you some money if the item is in your Flotilla store. The Association's web site has changed over the years, so if you have not visited it recently, please do so. There is a sub-tab on the Auxiliary site that will take you to the store, of if you go to the Association's Home Page, click on "MORE" and that will ultimately take you to the store.

As an FYI, for those of you who might want to wear a pin on civilian clothes that indicate the highest office you have achieved in the Auxiliary, there is a pin indicated on the first page of the Uniform (All Items) tab that shows the DCO/ANACO pin. It would go on a sport or suit jacket. I don't think they show the other levels, but I know the store has them. Contac me with any questions if you are interested. According to the site, they have reduced prices on a lot of items. I know they are trying to reduce their inventory on a lot of things, many of which will not be reordered. Contact me if there is something you cannot find, but which you thought should have been there, as I can find out if it is still available. You can place your orders directly with the store, and accept credit cards for purchasing items.

Before AuxData II ceased to exist and prior to the end of the federal fiscal year that resulted in the government shutdown, there were

operations. Patrols were conducted at Flotillas 21, 22, 25 and 29 with qualification missions held at **Lakes Allatoona and Lanier**. On the Lake Allatoona mission, Flotilla 22 certified two

new boat crew plus a member from the **Heartland Coastal District**, very unusual. At Lake Lanier, the qualification mission requalified two members each from Flotillas 25 and 29. Training continues, although during the shutdown, informally as member training. Across the Division, at least seven members are working on boat crew qualification, four at Flotilla 25 and three at Flotilla 29, plus one each working on Coxswain qualification at those Flotillas. Shoreside and dockside training can continue during the shutdown and funds allocation processes.

Annual Currency Maintenance has been completed for all five operations qualified members at Flotilla 25, and was underway elsewhere. Hopefully, the current funding restrictions will be lifted in time for this qualification requirement to be completed this year.

New training is underway, with Flotilla 25 hosting Auxiliary Paddlecraft (**AUXPAD**) training in conjunction with the American Canoe Association (**ACA**). The Southeast District Assistant Operations Officer (**ADSO-OP**) for AUXPAD conducted three days of training for four members of Flotilla 25 on the weekend of October 3rd to 5th. This training should lead to basic AUXPAD certification for all participants.

The Personal Watercraft Operator (**PWO**) program went inactive in 2020, with the last Qualification Examiner inactive in 2019. Previously, qualified members were available to requalify if a process can be authorized. Division 2 support is available to host a QE mission. A qualification mission has been promised for this year, but to date, no commitment has been made by District. There are at least three methods for conducting a qualification mission, and due to the lack of currency, all methods will require a waiver to re-start the program.

We have been informed that the Division's request for Personal Protective Equipment (PPE) was lost at Sector and not included in the most recent purchase. **Erik Amato**, the Division's new Rescue and Survival Systems Officer (SO-RS), has requested that all Flotillas resubmit their requirements for purchase as soon as funds are available. Changes this year are that all Coxswains are to be provided with inflatable (Type V) lifejackets.

At District Training (**D-Train**), the District Staff Officer for Operations (**DSO-OP**) presented a session on implementing and maintaining a successful operations program. His recommendation for facilities was 17 to 25 feet in length, and maintaining an active

operations program with continuous training. Generally, this is the program maintained in Division 2, but we need to assist as much as possible in Flotillas or areas without sufficient facilities or qualified personnel.


Latest Event from Flotilla 29 (September 13th Event 2025 at Lake Lanier)

Mates,

We are winding down the summer quarter. The advantage of program visits is that they can be conducted throughout the year. The numbers are not as high as we had hoped, but a couple of Flotillas show higher numbers than last year, which is excellent. We're working to increase our numbers, particularly in attracting new Program Visitors. Flotilla 29 is trying to get its Vessel Examiners to become Program Visitors-because they go hand in hand with each other.

One issue being reported is that some of our members are aging out—my thanks to them for many years of excellent service.

Some are already aware of my appointment as District Staff Officer for Program Visits. With this new role, I plan to implement changes that will increase our participation and motivate more members to get involved in the program. For those already engaged, I aim to boost their activity. I hope this will generate greater interest in making visits to support each Flotilla in Division 2, as well as in the other Divisions across the Southeast District.

The first suggestion is for Program Visitors, when meeting with new partners in the boating industry, to focus on dealerships that sell both new and pre-owned boats. We should ask these dealers to help us by handing out our brochures, packaged together with a schedule of this or next year's boater safety classes. An idea is to place this package in an envelope, ready to hand to the customer, so there is no extra work for the dealer.

Second, there was a program called the **Lighthouse Award** for achieving 1,000 program visits, which was discontinued. I am exploring the possibility of reopening this program. The Lighthouse Award is now used for public education, so we will need to come up with a new name. I am open to suggestions, so please feel free to send any ideas. More details about restarting this program will follow, as I understand it was quite effective.

Accomplishments:

- All five Division Flotillas are slowly digging their way through PPE inventory, Personal Locator Beacon (PLB) Registrations and AuxData II entry.
- Sector Charleston (SECCHS) finally settled on two versions for placing the PLB sequential numbers within the NOAA Registration process.
- Currently developing a Division wide spreadsheet list of all PLBs assigned to members. This
 is to be maintained by the SO-RS and sent to the SECCHS AUXLO and RSS Manager Dean
 Creed whenever it updates.

Opportunities:

• There is an urgent need for the OTO and the QE staff to sort out the proper procedure for overcoming the short fall of the number of PLBs available and the need for trainees to have the proper equipment while training and going through the QE process. Currently members ready for a QE must have a registered PLB prior to the QE session is scheduled.

Challenges:

• There was an unfortunate conclusion to the large PPE requisition that was sent to SECCHS this past April to fill the PPE needs for the Flotillas in our Division. The order was either overlooked or cancelled. The AUXLO, OTO and DIRAUX are looking into the issue.

This generates a large number of questions from our members and difficulty in fulfilling our requirement to provide our OPS members with all the safety items required to participate in the OPS program.

I am honored to serve as the newly appointed SO-VE for Division 2. My primary role is to support FSO-VEs across the Division and to help ensure our vessel safety program runs smoothly, efficiently, and in full compliance with procedures.

Key Procedures and Decal Allocation Timeline

Fiscal year and decal eligibility: Decals are issued by fiscal year. For the current cycle, eligibility runs from 6/30/2024 through 6/30/2025. Any Vessel Safety Checks (VSCs) completed after 6/30/2025 will count toward the 2026 decal allocation.

Allotment timeline: It typically takes about six months to determine each flotilla's decal allotment. This period includes tallying VSC totals, securing design approval from National and the U.S. Power Squadrons, and printing and distributing decals. How quantities are determined: A Flotilla's decal allotment equals the number of VSCs completed during the fiscal year plus an additional 10%.

2024 (Q2) VSCs completed: 446 2025 (Q3) VSCs completed: 843

Year-to-date total VSCs (current year): 1,218

Highlights and Impact

Our Division has demonstrated significant year-over-year improvement. This growth reflects the dedication of our examiners and directly contributes to safer waterways for the public. The increase also provides assurance that vessels meet

federal safety standards and that, in an emergency, they have the necessary equipment to save lives and summon help.

Next Steps and How I Can Help

Ensure all VSCs are logged accurately and in a timely manner so they count toward your Flotilla's decal allotment for the applicable fiscal year. Note the deadline context for planning: While the current deadline has passed, it is important to know for the next cycle. Next year's deadline date is 6/30/2026.

Congratulations to every Flotilla examiner who contributed to this year's strong performance. Your efforts make our waterways safer and strengthen our service to the boating public. I look forward to working with each of you to sustain and build on this momentum.


