- V. Business meeting, FC Anthony Lapicola
 - A. Call for additional agenda items—added to new business by Chris Cohan.
 - B. Guest introductions: SO-PE Sofy Rios; FSO-HR Nardi introduced prospective new members Tomás N. Regalado, Jr., Auddy Julio Leza, accompanied by his mother, Breezy Evia Leza and his sister; our other guests included: James Robertson, Sonia Blumenthal, and Hanna Ellis [who will soon transfer to Flotilla 65].
 - C. Approval of meeting minutes: Nardi motioned, Ventura seconded. Approved by acclimation.
 - D. Member welfare: looking for information on Shelly, Armando Framil is ill.
 - E. Division meeting report, given by FC Anthony Lapicola:
 - MST2 Feus wants at least 3 members from each flotilla to become a pollution responder, these responders will make a report as to what they find. There will be 3 training classes, must be available at least once per week. Need dedicated members to do this. Will likely be a lot of land calls to travel to spill sites, not likely to need boat travel. If interested, contact FC Anthony Lapicola who will contact Bill Tejero. This is a real commitment, do not apply if you do not have the actual time to volunteer. Training begins in May 2012—there is no risk for members as members will not deal with the actual hazards, or clean up activities. Member would be on call 24-hours per day.
 - Judith Hudson addressed metrics for flotillas which will include VEs [comparison of current numbers to past numbers], BSB graduates, number of AUX members, etc.
 - Standing Rules addressed, which F65 already submitted.
 - Division will not have a March 2012 meeting.
 - There will be a coxswain workshop which all coxswains must attend on March 13, 2012 @ 1930 at the Elks Lodge. There may be no orders issued to coxswains who fail to attend. If you plan on becoming a coxswain, you are welcome to attend, but it is not mandatory.
