A. Call for additional agenda items—no new items introduced.

B. Guest introductions:

- Alfredo Nardi introduced Ken Robertson who was on his way to having his membership package completed; Oliver Samy introduced by Gary Ellis, will likely be processed at the Opa Locka event. Grady O'Neal present.
- SO-CS Tony Miyar. Flotilla takes a vote to accept the WOW website as its website. FSO-SR Armas volunteers to take on the FSO-CS duties. All staff officers should be able to append the website. - E. Division meeting report, by FC Anthony Lapicola:
 - Flotilla 6-1 received award for best Flotilla. Trident device was presented to a member of Flotilla 6-1.
 - Lt. Abeyta announced that the filming crew was at Station Miami Beach—please ensure that whatever uniform of the day is on patrol, make sure it is correctly worn and that all patrol members are wearing the uniform correctly.
 - Lt. Abeyta will get more involved in getting boats inspected as this may spur boat owners to have their vessels inspected.
 - Joel Auerbach wants a Sea Partner volunteer—volunteer gives lectures on maritime issue. Division has extra money which will result in all facility owners getting a first aid kit.
 - Calling Tree: June 1-October 1 2012 is hurricane season, which means there will be a calling tree, 4 names have been deleted, 10 have been added. The Flotilla needs 3 more volunteers as we now have 5 more leads and 4 alternates were needed. Bob Hopps, Aberlardo Lopez de Queralta volunteered as leads; Steve Cruz volunteered as an alternate. Search for leads and alternates will continue.
