#### **Keeping Operations Safe and Clear During Covid-19**

Yes, we are back up and operational with guidelines. Covid -19 has changed the way the world does things. Vessel exams and Program/Partner visits were we extend our public outreach. In March Commodore Barth ordered all D7 to cease operations. June 17 USCG CAPT Youngs memorandum set forth the opening of our public outreach with strict compliance to CDC Covid -19 guidelines. June 18 DSO-PV Barbara Birchfield outlined in detail these guidelines. But we need written permission from FC, in detail before we proceed. Confusing at the least. 



# Coast Guard rescues man after boat takes on water 13 miles west of Clearwater



CLEARWATER, Fla. — The Coast Guard rescued a 48-year-old boater Tuesday after his 26-foot boat started taking on water 13 miles west of Clearwater, Florida.

Rescued was North Redington Beach native, Mike Demarinis, 48.

A 29-foot Response Boat-Small II crew from Station Sand Key responded; once on scene the crew used a dewatering pump. The Coast Guard boat crew escorted Demarinis and his boat back to his home in North Redington Beach.

At 3:53 p.m. Sector St Petersburg watch standers received a 911 transfer call from Pinellas County dispatch. Demarinis stated his boat was taking on water and he needed immediate assistance.

Demarinis stated sea conditions caused the boat to take on water and his bilge pump would not operate. Sector St. Petersburg watch standers reported 6 mph winds and 2-foot seas.

There were no reported injuries.

"When you're getting ready to launch, ensure all safety equipment is on board and working properly," said Kevin Coyne, a command duty officer at the sector. "Also, make sure to familiarize everyone with the equipment."

#### Bill Zinner passes the FSO-IS to Bill Ackerman.


"Bill Ackerman has agreed to take over the position of FSO-IS for Flotilla 7-16. When things are normal the job can be hectic at certain times of the year: January means Member Letters for all to provide people with a summary of their Auxiliary related activities throughout the year; May means an uptick in vessel exams and public education activities as snowbirds return to the Bay area; Fall reminds members of any qualifications they may need to address to keep certifications active. FSO-CMs have access to Flotilla members' statistics so they can produce reports for Leadership to create programs for the membership. A lot is expected of the FSO-CM: accuracy, quick response, leadership and patience. Bill has all these qualities. He has taken over this position at the start of a transition from one program (AUXDATA) to another (AUXDATA II). In addition to sorting out the new program so he can use it effectively, Bill will need to help our members do the same thing. The new program provides the opportunity for them to take an active role in putting their own data into USCGA records. The FSO-CMs will have an overseer's role to assure the accuracy of a member's input but, as members learn the process, the result should be more member-involvement and a clearer appreciation of the importance of the resultant statistics. After all, our only currency is the hours of work donated by members and Flotillas. The results of the gathering of these statistics can be awards for members and units and backup for the argument made by the Auxiliary of the value of our efforts. This has a direct bearing on government's decision to fund our organization. I expect that Bill will be able to teach the membership how to interact with the new program effectively. The coming year will be a time of transition in many ways. With the organization shut down members have an opportunity to spend some of their free time seeking training via the many on line classes available from the Coast Guard and FEMA (to name a few). We are looking east to the African continent where tropical storms form off the west coast and begin their march toward the Americas and their environs. Coasties - active and Auxiliarists - may yet have critical roles to play preserving the safety and sanctity of our communities. We watch the upcoming elections where we can exercise one of the most important, unique privileges and responsibilities citizens of any country can have. All in all, the role of FSO-CM also has a part in this effort and I know Bill is the right person for the iob."




### 7-16 Guys are AMAZING!!!



# The Long Blue Line: Gun captain and African-American war hero Louis Etheridge

During an escort of Convoy ON-166 from Ireland to the U.S., Chief Steward Louis Etheridge, aboard Coast Guard Cutter

Campbell, commanded an 11-man African-American gun crew of stewards, mess attendants and steward mates. On Feb. 22, 1944, Campbell faced-off against German submarine U-606 in which Etheridge and his gun crew decimated the sub's crew and rendered the U-boat defenseless. Etheridge earned the Bronze Star, the first military medal bestowed on an African-American Coast Guardsman for combat heroism.

In the 1970's, they formed flotillas in sole-state waters to meet local demands for water safety.

#### FC Beacon News Letter Article October 2020

Flotilla 7-16, here we are for another Beacon Newsletter in 2020. I was truly hopeful that we would be back a "New Normal" by now. Unfortunately, that has not occurred. We have made some progress with some operational activities in the last couple of months

- We were approved to do PV (Program Visits), VE (Vessel Safety Exams)
- In September we at 7-16 went live with radio guard watches for CGA Boat operations.
