## National Safe Boating Week: United We Accomplish So Much!

Activities during the National Safe Boating Week (NSBW) event at the Gandy Ramp on May 24 were successful. Support from Station St. Petersburg, Florida Fish and Wildlife Commission, and Division Auxiliarists was strong and the goal of making the public aware of safe boating was achieved. Activities included a live remote radio broadcast by the "Captain Mel Show", to Vessel Examinations (VE) and a flare shoot.

Captain Mel Berman aired his "Captain Mel's Show" live from the Gandy Boat Ramp from 6AM and 9 AM. He mentioned the Auxiliary's NSBW activities at the ramp every 15 minutes and Tim Teahan responded (for about three minutes) on air to a caller's question about the location of safe boating education courses in Tampa Bay.

#### Submission Guidelines:

**The Intercom** is always looking for articles about Auxiliarists, stories of interest and photographs. Your articles need not be long; just make sure you include all of the basics: **Who** are you writing about? **What** is the topic or event? **Where** does the story take place (location)? **When** did, or **when will** this event take place, and finally, **Why** is this of interest, or **How** was this accomplished? Provide as much information as possible, and always include your email address or phone number. When typing, please **do not** use all caps.

**Photographs** should always be high resolution images. Use a digital camera that shoots images at 3 mega-pixels or better. Do not reduce the image or crop the photo unless you are an experienced user of one of the high-end photoediting programs, i.e., *Photoshop CS®*. The final print resolution should be 300 dpi. If this sounds confusing, just send the image straight from your camera and add a description that includes who and what is depicted in the photograph, and the name of the person who took the photograph.

Take a camera with you everywhere! Vessel examinations, member training, patrols, Public Education programs and fellowship events are all great photo opportunities. Be proud of everything that you do and brag a little bit about each other! It is a wonderful way to express appreciation for a member's efforts.



iary services Division-wide over at least the next month or so.

Mel Berman's long-standing support of safe boating in Tampa Bay was recognized with a presentation of a plaque bestowing honorary Auxiliary membership. Mel was very appreciative of the honor. Vessel Examiners from several Division flotillas including but not limited to Flotillas 72, 75, 79 and 7-16 performed well over 30 vessel inspections from 0730 until about 1200. Don Rimel from FL 7-16 conducted his 100th VE by mid-morning.

VEs distributed West Marine discount coupons in addition to copies of float plans (two-sided) and a list of safe boating courses available at all Division flotillas. Copies of the latest brochure describing Tampa Bay security zones and decals about VHF marine radio use in distress situations were also

Approximately 15 expired flares were shot from an area east of the ramp. Auxiliarists and Florida Fish and Wildlife (FWC) officers participated in the shoot.

WFLA Radio created a sales package to present to potential advertisers to participate in the remote broadcast, which was to include a table for exhibit. Despite strong efforts by WFLA sales representatives, no packages were sold, due largely to advertiser involvement in a boat show at the Fairgrounds the previous weekend. The WFLA sales manager related that companies they approached would have more seriously considered exhibiting at the Gandy Ramp event had they not already committed to the Fairgrounds boat show.

schedules at all Division flotillas and copies of a two-sided float plan were available on a table at the ramp, in addition to a display of life jackets, emergency whistles and other promotional material.

At 0800, participants performed 'Morning Colors,' with members of the Auxiliary, FWC, the Coast Guard, Mel Berman and Tampa Police Department represented. The National Anthem was played.

Station St. Pete provided a 41-foot UTB for exhibit purposes. Several boaters viewed the craft from the dock, with UTB crewmen describing the vessel and equipment.

Two FWC officers and Tampa Police Department Officer Novack were in attendance. The FWC officers distributed more than 60 emergency whistles to boaters launching from the ramp and participated in the expired flare launch.

A news release was prepared and distributed to more than 70 Tampa Bay TV, radio and newspaper and recreational website on May 12 describing the May 24 events, including the Tampa Tribune and St. Pete Times outdoor recreation columnists. A notice was published in the Tribune's Friday Extra May 23 edition and was mentioned in columns by Frank Sargeant (Tribune) and Terry Tomalin (St.

Pete Times) earlier in the week preceding the event. In addition, Mel Berman mentioned his involvement in the event during his May 17 show broadcast.

The concept of partnering with Captain Mel was a solid one and despite the fact that boat launching at the Gandy Ramp on May 24 was uncharacteristically slow, due likely to adverse weather reports (40% rain) for the day, as well as the price of fuel and the fact that recreational boaters are more likely to go boating on the Monday of Memorial Day than the weekend Saturday. Perhaps holding future NSBW events on the Monday of Memorial Day might be more fruitful. Despite this, this year's activities were quite successful. Many thanks to all who participated!

During the past months we conducted the BS&S class for members with the participation of mostly new members that upgraded their status from IQ to BQ. The divisional Crew Member training was also a success. Our Flotilla members showed that we could improve and grow in qualifications beyond what was expected. We have five and three-quarter new crew members that will start participating in operational and safety missions. The three-quarter? One of the six members who completed the training must still pass the Qualifying Examination.

On Saturday June 14<sup>th</sup> the Aids to Navigation (ATON) verifier course was conducted at Flotilla 79 with the participation of Bob Easterday, FSO-AN, and some of our new and very active members. They earned the ATON Verifier Qualification.

Vessel Safety Checks (VSC) inspections have been increasing and our new FSO-VE, Richard "Beetle" Bailey, has been doing a great job

setting up the VSC station at Williams Park, getting members involved and assisting with getting other members VSC qualified. All of our efforts are making the waters of the Tampa Bay Area a safer place for recreational boaters.

During May 2008 there were 53 Recreational Boating Safety Visitation Program (RBSVP) visitations conducted by Flotilla 74 members. We have four new Partners with no deletions to the program. Our Flotilla is currently servicing 62 RBSVP Program Partners.\*

In a continuing effort to expand Marine Domain Awareness (MDA), contact was made with the Polk County Natural Resources Division. Technical support was provided in rewriting their trifold pamphlet, "Boating Safety in Polk County." In Addition to code ordinances, boating safety course information was provided. USCG Auxiliary Flotilla 74 is in the first position of references by name and telephone number, which can be found on the reverse side of the pamphlet. This

pamphlet will be distributed in Polk County in addition to other safe boating materials.

## Communications, Terence Affeld, SO-CM

The Division Net Drill was a success thanks to our Flotilla Communications Officers and Station St. Petersburg.

In June 2008 a new Personal Qualification Standard for Auxiliary Communications was developed and released and will be required for all new Watchstanders effective August 1, 2008. Members holding Auxiliary Communications (AuxCom) qualification earned prior to 1 August may continue to operate and own radio facilities indefinitely.

There are about 13 pages of Qualifications to complete under the direction of the FSO-CM or his designee. This was brought about due to the extensive use of new technologies involving Rescue 21, Global Marine Distress & Safety System (GMDSS) and new roles for the Auxiliary since 9/11.


All FSO-CMs have been sent the 36 page document outlining the Telecommunications Operator designation with links to the new Personal Qualifications Standard (POS).

## Member Training, Eleazar Escorihuela, SO-MT

Our Personnel Service Officers have done a great job recruiting new members who now need to be trained in our various qualification areas. New members should be mentored and coached, otherwise they stop participating. Encourage new members to receive training in multiple qualification areas. This way they may rotate their activities and make participation in the Auxiliary more interesting, and they may participate in any activity of their choice. Without training and coaching members lose interest and leave. While recruiting is important, let's keep in mind that retention is a key point to consider as well.

A Commercial Driver's License (CDL) and a Military License Qualifi-

cation programs are being held at the Coast Guard Air Station in Clearwater. I have been training enlisted persons so they may obtain their CDL and have a career alternative when they get back to the civilian world. I have also been training military personnel in driving skills and truck inspection as well as safety rules for fuel trucks. Lou Miosi has been planning the activities at the Air Station and taking care of the materials needed for these programs. As these programs continue, others will be trained in testing enlisted personnel for the Military License.

I would like to thank the Flotilla Commanders from 72, 73, 74 and 78 for their great participation in Member Training (MT) initiatives as well as the Flotilla Member Training Staff Officers from Flotillas 73 and 74 for their outstanding work. Operations (OP) has being doing their part by holding the Division-wide Crew Member Training which was a success. Other Staff Officers are encouraged to follow the examples provided by OP and MT and steps to start getting new members' feet wet.

Here is what our flotillas have been up to:

**Flotilla 72:** The 2008 Instructor Training (IT) Workshop was conducted and completed by all qualified members. Some members participated in the Team Coordination Training (TCT) eight hour training at Flotilla 79. Two members completed their Vessel Examiner (VE) qualification. The Sexual Harassment Prevention (SHP) Workshop was also conducted. The Flotilla Commander of 72 also proctored 4 technical tests for a Flotilla 74 member.

The Auxiliary Operational Polo Shirt has USCG Auxiliary embroidered in white on the left front side and the Auxiliarist's last name embroidered in white on the right front side. The shirt is dark blue, has no pockets, and is made of 100% combed cotton.





The VE Polo shirt is authorized for wear as an optional uniform shirt as part of the Undress Blue Summer (Bravo), Working Blue, Operational Dress (OD) and Hot Weather uniform. Ref: Auxiliary Manual (AUXMAN), Chapter 10, Section A, A.7. Only the Dark Blue shirt is authorized, No other color is authorized per the AUXMAN. ®



## Happy Birthday USCG Auxiliary!

On June 23, 2008 the USCG Auxiliary celebrated its 69th birthday. In honor of this occasion we offer this brief history of the Auxiliary found on Flotilla 75's new web page. Congratulations to Flotilla 75 on their new 'home' on the web, and to Joe Parrish, FSO-CS, who made this possible.

"When the Coast Guard "Reserve" was authorized by act of Congress on June 23, 1939, the Coast Guard was given a legislative mandate to use civilian volunteers to promote safety on and over the high seas and the nation's navigable waters. The Coast Guard Reserve was then a non-military service comprised of unpaid, volunteer U.S. citizens who owned motorboats or yachts.

"Two years later, on Feb. 19, Congress amended the 1939 act with passage of the Auxiliary and Reserve Act of 1941. Passage of this act designated the Reserve as a military branch of the active service, while the civilian volunteers, formerly referred to as the Coast Guard Reserve, became the Auxiliary. So, February 19 is formally

recognized as the birth of the Coast Guard Reserve while June 23 is recognized as the birthday of the Coast Guard Auxiliary.

"When America entered World War II, 50,000 Auxiliary members joined the war effort. They guarded waterfronts, carried out coastal picket patrols, rescued survivors from scuttled ships and did anything else they were asked to do. Many of their private vessels were placed into service.

"After the war, Auxiliarists resumed their recreational boating safety duties. The Auxiliary's four cornerstones - Vessel Examination, Education, Operations and Fellowship - were established and remained the Auxiliary's pillars into the 1990s. Today the four cornerstones have been re-defined as Member Services, Recreational Boating Safety, Operations and Marine Safety, and Fellowship.

"The well-known <u>Vessel Safety Check</u>, a free examination available to any recreational boater, helps boaters ensure their craft complies with Federal boating regulations.

"As for Education, the Auxiliary teaches boating safety to recreational boaters of all ages.

"The Auxiliary operates safety and regatta patrols and is an integral part of the Coast Guard Search and Rescue team. Auxiliarists also stand communication watches, assist during mobilization exercises, perform harbor and pollution patrols, provide platforms for unarmed boarding parties and recruit new people for the Service.

"Following passage of the Coast Guard Authorization Act of 1996, the Auxiliary assists the Coast


