#### It wrote the following:



## AUXAIR Report January 2023 by John C. Landon

Orders to fly to Key West / Florida Straits to search for Cuban Migrants on Jan 6th. Picked up crew at Sarasota-Bradenton Airport (KSRQ) and proceeded to the straits. However, as we reached the Everglades, Sector diverted us back to the Skyway Bridge area to search for a small sailboat that was disabled near the Skyway Bridge. The captain was a 93-year-old man who was reportedly having some issues communicating with sector. Searched the area for over an hour and guided a Coast Guard small boat to a suspected target which they boarded but found no issues. Returned to KSRQ to drop off crew and debrief. Issued new orders for 1-10-2023 to fly to the Florida Straits Picked up crew at SRW (Southwest Florida International Airport, Fort Myers) and proceeded to the Straits, refueled in Marathon and continued flight in the Straits to the Marquesas Keys then returned to KSRQ to drop off crew. Returned to KCLW (Clearwater Airpark) at sunset, logging almost 6.5 hrs. flight time.



20 JAN 2023 FM: CHDIRAUX TO: ALAUX ALAUX 004/23 Subj: AUXILIARY COVID-19 GUIDANCE - VERSION 5

- 1. All Auxiliarists are highly encouraged to review the latest version of the Auxiliary COVID-19 Guide which has been posted in AUXDATA II and on the Chief Director of Auxiliary (CHDIRAUX) website at: Auxiliary COVID-19 Guidance. To review the guide in AUXDATA II, login to AUXDATA II; from the AUXDATA Navigation Bar select "More," then "Files," and then select "Libraries." The guide and other relevant COVID-19 information are located in the folder, "CG Auxiliary COVID-19 Guidance." Questions regarding the content of the guide should be directed to the appropriate Auxiliary Chain of Leadership and Management (COLM).
- 2. The following are highlights within this revision (review the Guide for more details about each item):
- a. The temporary restriction that requires all Auxiliarists to be fully vaccinated prior to volunteering for an assignment to duty (ATD), has been suspended. All Auxiliarists may request ATD in any Centers for Disease Control and Prevention's (CDC) COVID-19 Community Level without the need to provide proof of a negative COVID-19 test unless otherwise requested in accordance with the "Meetings and Conferences" section of the Guide.
- b. District Directors of Auxiliary (DIRAUXs) and Order Issuing Authorities (OIAs) should follow the CDC guidance and recommendations applicable to their AOR's current CDC COVID-19 Community Level. Please review the following regarding CDC COVID-19 Community Levels: COVID-19 by County | CDC.

- c. All Auxiliarists are expected to view the CDC COVID-19 page at Coronavirus Disease 2019 (COVID-19) | CDC for further information on transmission, prevention, symptoms and emergency warning signs, people at higher risk for severe illness, exposure risk, preventing infection, etc.
- d. Community Level mask wear guidelines follow:
- (1) CDC COVID-19 Community Level of High: All Auxiliarists shall wear a high-quality mask. (An example of a high-quality mask is a cloth mask that properly fits over the nose, mouth, and chin to prevent leaks; has multiple layers of tightly woven, breathable fabric; has a nose wire; and has fabric that blocks light when help up to a bright light source. Another example of a high-quality mask is a procedure mask (aka surgical mask) with a proper fit over the nose, mouth, and chin to prevent leaks; has multiple layers of non-woven material; and a nose wire.) See CDC's page on types of masks and respirators for further information: Masks and Respirators (cdc.gov)
- (2) CDC COVID-19 Community Levels of Medium and Low: Masks are optional for all Auxiliarists unless otherwise directed by DIRAUX or the cognizant Coast Guard OIA.
- e. Auxiliarists, regardless of vaccination status, may apply for and attend mission-critical Auxiliary C-schools. Full COVID-19 vaccination is still required to apply for and attend non-mission-critical C-schools. Please review ALAUX 046/22, Resumption of In-Person Auxiliary C-schools, which identifies mission-critical Auxiliary C-schools and can be found at the following: 2022 ALAUX (uscgaux.info), for further information.
- f. Currency Maintenance can be found in ALAUX 048/22, Calendar Year (CY) 2023 Annual Currency Maintenance Requirement Tracking for Crewmember, Coxswain, PWC Operator, and Nighttime Certification, at 2022 ALAUX (uscgaux.info). Any questions should be directed to the servicing DIRAUX and Operations Training Officer (OTO).
- g. All official Auxiliary engagement activities that entail attending other-than-Coast Guard or other-than-Auxiliary conferences, conventions, or other large gatherings are authorized in accordance with CDC guidelines, Coast Guard policy, and Auxiliarists shall follow State and local policy if more restrictive.
- h. All Auxiliary gatherings (meeting, conferences, training, etc.) are authorized to be planned and executed in any CDC COVID-19 Community Level without the need for further Coast Guard or Department of Homeland Security (DHS) clearance or waiver. This is regardless of vaccination status.
- i. Official travel is authorized for all Auxiliarists regardless of vaccination status. Auxiliarists must continually check the CDC COVID-19 Community Level for the areas

they will be traveling to and from. In addition, Auxiliarists must review CDC's travel notices at: Travelers' Health | CDC and Domestic Travel During COVID-19 | CDC 3. DIRAUX offices, Coast Guard units, and OIAs are continually assessing operational risks posed by COVID-19 and developing mitigation strategies in advance of mission performance. They remain the best sources for guidance regarding Auxiliary assignments to duty within their respective areas of responsibility. All Auxiliarists are expected to help them by exercising caution and adhering to Coast Guard guidance.

# U.S. COAST GUARD AUXILIARY FSO-PV REPORT

What's a "FSO-PV" (Program Visitation)?

Program Visitors are largely responsible for the first contact between recreational boaters, boating service providers. and the Coast Guard Auxiliaries. We visit businesses who provide necessary services to the boating public; boat sales, boat repairs, boat accessory sales, fishing information, and docking services, and provide them with materials to distribute to their customers. Being a PV offers not only the opportunity to be of service to connect the boating public to the Coast Guard Auxiliary, but also offers the experience of visiting many interesting businesses and meeting many interesting people.

We identify businesses in our area frequented by boaters. Not just those who take care of their boats but those who serve the boaters themselves, such as restaurants, fishing supplies, libraries, chambers of commerce, and specialized clothing and supply stores. We educate them about the role the Auxiliary plays in recreational boating safety. We ask them if they would like to partner with us by providing information to boaters who frequent their business. We provide a literature rack and fill it with various Cost Guard publications. We also include information about our flotilla's specific activities including boating safety classes and vessel examinations. We ensure that the business has our contact information in case they run out of material before we return, or if they or a customer have questions about any aspect of recreational boating safety.



Racks and supplies in place, restocked and on display in all clients visited. We have good stock levels of racks and supplies to fill them with in the flotilla classroom. Flotilla 11-10 is constantly working on recruiting new Partners and more will be onboard in the near future. No new PVs have been qualified.





The family requested that his ashes be dispersed at sea as was his final wish. A number of obstacles occurred, but were resolved. The final plan involved Harvey Prior embarking the family on his facility from the Seminole Boat Ramp and transferring them to a Coast Guard boat. Both boats proceeded three miles offshore for the service. Upon returning to land, the Coast Guard boat transferred the family to Harvey's boat to dock at the Seminole Ramp. The transfer was necessary as the Coast Guard boat was too large to dock at the Seminole ramp and the road to the Sand Key Coast Guard station was blocked due to an event. The weather was overcast and wind was a bit brisk, but held up well enough. The proceedings were successful with the family pleased at all of our efforts.

FM: CHDIRAUX TO: ALAUX ALAUX 005/23 Subj: BOATING SAFETY APPLICATION FOR SMART PHONES

1. The Coast Guard Boating Safety application has allowed smart phone users on the Apple and Android mobile operating system platforms to input a profile, email a float plan, review safety equipment requirements, and obtain emergency assistance, as well as other features. Unfortunately, the application is no longer available in the application stores since updates have not been possible.



- 2. The Coast Guard is exploring the future of the application and hopes to put out additional information in the next 90 days. In the meantime, Auxiliarists should advise anyone who is interested in the application that it is not available, and users who have the application on their smart phones should be advised to delete it until further notice.
