## **Marine Safety**

Proposed Events April 13 St Johns River Blessing of the Fleet April 25-27 Metro Park Boat Show April 27 Jax Opening of the Beaches Parade (flotilla participation canceled due to parade and the boat show happening on the same day. Oct 25-26 Jax Beach Air Show

#### 1. Private ATON

A Private Aid that is no longer there was bought to the attention of the SO-NS by the FSO-MS. The SO-NS contacted Ant Jax and this aid was removed from the 2025 Light List.

#### 2. Abandoned Shipwreck Act of 1987

This act gives Federal ownership of abandoned wrecks and provides the public access for recreational and educational purposes.

#### 3. DAN Divers Alert Network

This is a membership of individuals and organizations sharing an interest in diver safety. DAN operates a 24 hour national hot-line to provide advice, early treatment and hyper-bardic treatment for persons suffering from diving related injuries. Emergency calls 919 684 8111 or non emergency calls 919 684 2948.

#### 4. Marine Safety Alerts

A. LED Lighting may effect your VHF Radio and AIS system. It has caused interference with the DSC part of the VHF also. If you are having problems, turn off your LED lighting and use the radio. If the problem goes away, then that is it.

Do not place LED lighting, including spot lights, near your radio's antenna.

#### B. MS Alert 06-25

Bow seating type boats have been dangerous when encountering large waves. In the Charleston S. C. area and the Hudson River in Manhattan N. Y. C., bow seating caused 9 passengers to be ejected when the boat hit a large wave. 1 person was killed by the boat's propeller.

#### 5. Automatic Identification System (AIS)

AIS shows a picture of other vessels in your area by displaying and identifying them on a screen. This helps you to navigate more safely.

Required Vessels to have AIS include- 65' and up commercial vessels, passenger ships, fishing vessels over 65', towboats over 26' and 600 HP, vessels over 300 GT and on an international voyage. 150 passenger capacity and up vessels.

Three classes of AIS are A, B and C. A having the most features. Recreational boats wanting AIS usually get a Class B to suit there needs.

When you get a VHF radio, get the MMSI number, you then add AIS to that through the BoatUS register form.

If you sell your boat with the VHF radio, the new owner must transfer the MMSI to him. Transfer of one's name applies to EPIRBS as well, DO NOT keep it in your name.

#### 6. New Product

At the Boat Show- a boat or any trailer plug contains adapter to not only power your trailer lights but other lights as well. If you do not have a trailer but your vehicle has the plug you can power accessories without having to wire the vehicle. Just plug in your extra lights etc and they work. No splicing wires, looking for a ground etc. viaircorp.com

#### 7. Red Tide Tech

Mote Marine Laboratory developed three products to combat Red Tide. Red Tide, an algae bloom, is defined as the presence of at least 100,000 red tide cells per liter of water for at least 30 days. Two of the three products use plant based chemicals and the third uses bubbles to "pop" the cells. They can be deployed by a crop duster or a vessel or even back pack mounted sprayers. The chemicals do not

do greater harm to the environment than the red tide is already doing. This is science at its best, not just monitoring the problem, but coming up with solutions.

8. Permits are approved for new Marina

Rivers Edge and a 125 slip Marina permits are approved for the Southbank of the St Johns River. It will be bulk headed and include a Kayak Launch Site and a Water Taxi stop.

9. Fl. Governor to Stop Random Boat Inspections

The Governor stated that boaters who are NOT doing anything wrong and just enjoying themselves boating should not be stopped for a random inspection by state or local officials. He proposes a Freedom Boater Decal to be issued by the state when registering your boat that the boater themselves inspected the boat and has all the equipment to be in compliance. This does not affect U.S. Govt. (USCG and Customs) boats from stopping boaters.

A USCG Auxiliary VSC decal was not mentioned. Our District Office should bring this up to the Governor, who may not be aware of the Aux VSC. If the Governor tells boaters to get an Aux VSC, this will enliven the VSC program and more boaters will ask for it to be done.

10. Disabled or Special Needs PFDs

PFD-A corporation makes life jackets for disabled persons.
