Marine Safety

Proposed Events: April 13 Blessing of the Fleet April 25-27 Metro Park Boat Show Oct 24-26 Jax Beach Air Show

1. Federal Registers

A. Monday Feb 24th Presidential Administrative Order Continuation Movement of U.S. Registered Vessels are Not Authorized into Cuban Waters.

B. Friday Feb 28th EPA- The National Pollutant Discharge Elimination System Renewal for Boat Manufacturing- uses resins, gel-coat, fiberglass and paint coatings. Shipbuilding and Repair Facilities- repair and repaint

C. Monday March 17th USCG Final Rule effective 17 March 2025 Gulf of America Renaming in Regs 33 and 46 CFR.

2. Florida Right to Clean Water This amendment gives Florida residents the right to sue legislators when the water becomes unclean. Floridarighttocleanwater.org

3. Sea Legs

This boat is amphibious. It has wheels that connect to the hull and fold up when waterborne. They fold down and the boat drives itself out of the water.

They come in open center console type or the new enclosed cabin. sealegs.com

4. Flux Marine

Flux is an Electric Outboard and you can get them with a few selected boat types. Fluxmarine.com

5. Dumas Boat Models

You can get USCG boat models from this company. The 40', 41' in 15" and 31" and the new 154' Fast Response Cutter are available.

6. ALCOAST Message

ALCOAST Message 094/25 Automatic Inflatable PFDs may not fully inflate at or below 32 degrees F. Users need to become familiar with the manual operation to fully inflate them. Use Caution from 15 to 32 degrees F. Consider using Type 3 PFDs doing this time.

7. Home Made Vessels

To Register and Title a Home Made Boat in Florida the following is required.

Form HSMV 82040 Application for Certificate of Title OR Form HSMV 82041 Application for Certificate of Title and Registration Copy of the Bill of Sale or Receipts from the boats purchase.

For vessels less than 16' Form HSMV 87002 Vessel Statement of Builder For vessels 16' or more Form HSMV 87002 Vessel Statement of Builder And a Certificate of Inspection from the FWC. Contact the FWC for an appointment. FWC will provide the Form FWCDLE 126. Certificate of Inspection for Home Made Vessels The forms and the title and registration fee must be submitted to the DMV and also showing all taxes have been paid.

The State of Florida will issue a Hull ID number. It will start with FLZ.

Then the boat owner will be required to carve, burn in, stamp, embossed or otherwise permanently affix the number to the starboard side of the transom and if there is no transom, to the outermost starboard side of the hull.

If you find a boat with FLZ as the first part of the HIN, then you know it is a homemade boat. State Abbreviations followed by a Z let you know it is a homemade boat and which state it was from. Example New York NYZ, New Jersey NJZ.

8. Florida Boating Safety Bills

There are 5 new bills about boating safety to be voted on this legislative session.

SB58- Killing unborn child in a boating accident would be a murder

CS/SB 628- stiffer penalties for collisions and accidents causing casualties, also stiffer penalties for reckless and careless operation and suspension of vehicle driver license for BWI (Boating While Intoxicated) This would be known as Lucy's Law. Lucy Fernandez was a teenager killed in a boating crash in Biscayne Bay, Miami.

Changed Definition of Livery.

HB289- stiffer penalties for collisions and accidents causing casualties

SB 1388/HB1001- Boater Freedom Act, Prevents Law Enforcement to perform a safety inspection when no probable cause. Provides Clean Marina grants to Marine Facilities.

9. Boaters Guide to Fed Reqs for Rec Boats

This pamphlet is out of date with the recent (last 2 years) changes.

The Auxiliary states it is to costly to print out another version.

All updates will go to a file. VEs, PVs and all concerned can go to this file and update the pamphlets on your own.

BE AWARE- On Page 5 (FIVE) in the pamphlet And on the link, it Still shows a boat with Florida Registration Numbers and showing the State Decal on the Starboard side. THIS IS INCORRECT. The decal goes on the PORT SIDE. I informed the pamphlet people of this problem when the pamphlet first came out and they refused to correct it.

Global Position Indicating Radio Beacon. The difference between an Epirb and a Gpirb is the Gpirb is location enabled. It pinpoints its location so rescue can find you more quickly. The Epirb has a bigger area to locate you.
