OCTOBER Early in the month registered, certified letters are sent to

members who have not paid their 2013 dues giving them a 30 – day notice to pay. A Change of Membership Form (7035) is included with the letter giving them an opportunity to resign and return their Auxiliary ID card, or retire (if elegible) and return their AUX ID card. Members who have not paid are

called again.

NOVEMBER On the first of the month, disenrollment processing is begun -

FC→DCDR→ DSO-HR→DIRAUX. The contents to be sent

are the completed 7035 Form, a copy of the letter that was sent to the member, receipts from the mail certification & registration, and the ID card. They should be stapled or paper clipped together, checked by a second set of eyes, signed appropriately and sent. If the ID card cannot be collected, a record of the dates and ways that attempts to contact the member were conducted should be written on the form or a separate sheet of paper and attached. Make a copy of everything before sending.

Flotilla Commander & Flotilla Vice Commander:

- Must have been a member of the Auxiliary for one year prior to the date of election (counting from the date of enrollment in AUXDATA).
- Must have an OSFAV determination recorded in AUXDATA by the date of the nomination.
- Must have successfully completed the APC (Auxiliary Procedures Course) or the Flotilla Leadership Course.
- Must have successfully completed ICS 100 & 700
- Must be a member of the flotilla in which he/she is seeking elected office
- Must meet one of the three following requirements:
 - 1. Must be certified (interim certification is acceptable) in one of the following:

•	Surface Operations	Air Operations
•	Instructor	Aids Verifier
•	Watchstander	Trident specialty
•	Public Affairs specialty	Vessel Examiner
	Recreational Boating Safety Program Visitor	Interpreter

- For the Trident specialty and Interpreter, the candidate must present a memorandum from the Coast Guard OIA (Order Issuing Authority) or Auxiliary program manager at the next highest level stating that their status is qualified, active and current in that program.
- o **OR** have served as a staff officer or elected officer at any level for two (2) years
- <u>OR</u> HAVE 25 HOURS OF DOCUMENTED ACTIVITY IN Auxiliary programs or mission areas listed in the AUXMAN Chpt 2, Section B, pp 2-5 through 2-20.
