The Alternative Working Uniform Program?

The Alternative Working Uniform Pilot Program (AWUPP) is being conducted in the 1st Southern (1S) and 8th Coastal Regions (8CR) of the USCG AUX from 1 OCT 2021, throug 31 DEC 2022. The Program's purpose is to introduce the new Alternative Working Uniform that members may opt to wear instead of ODUs or the new Coast Guard CGU being rolled out over the next two years to active duty. The tucked ODU is no longer an authorized uniform since 12/31/21. TheCGU will be made available to Auxiliarists in Fiscal Year 2024 when the Untucked ODU will begin to be phased out. The program is allowing members of the 1S and 8CR evaluate the AWU's performance. The uniform is authorized anywhere the ODU is currently authorized for wear.

Galveston visited by CG Academy 3/c cadets aboard the Barque Eagle, June 2022:

At 295 feet in length, the **Barque Eagle** is the largest tall ship flying the stars and stripes and the only active square-rigger in United States government service. Eagle has served as a classroom at sea to future Coast Guard officers since 1946, offering an at-sea leadership and professional development experience as part of the U.S. Coast Guard Academy and Leadership Development curriculums. Aboard were 3/c cadets from the academy

completing their 3-week coastal sail. Several members of Flotilla 7-4 and Sea Scout Ship 7-4 were on hand to the at-

tend the open house held Saturday 11 June. In addition, a welcome picnic was held for all new CGAS (CG Academy Scholars) and CG Academy incoming Swabs (Freshman, 4/c) from Texas was held in Galveston concurrently. It was the first time **Eagle** has visited the Texas shores since 1972.

Boating Safety - The Latest Statistics: The U.S. Coast Guard released statistics on calendar year 2021 recreational boating incidents, revealing that there were 658 boating fatalities nationwide, a 14 percent decrease from 767 in 2020. From 2020-21, the total number of accidents decreased 16 percent (5,265 to 4,439) and the number of non-fatal injured victims decreased 17 percent (3,191 to 2,641). Alcohol continued to be the leading known contributing factor in fatal boating accidents, accounting for 86 deaths — or 16 percent of
