

# Minutes 11 JAN 2020

#### Call to Order/Pledge/Attendance/Guests

The meeting was called to order at 1000 hours, by FC/CS/MS: Shapovalov. The pledge was said, and attendance was taken. There were no guests.

#### **Old Business**

A motion to accept the minutes was made by member Aux Moore and seconded by FSO-MA: Maung. The November 2019 minutes were approved as written, unanimously by the members. There were no minutes for December because there was no separate Flotilla 7-4 meeting. The COW was held in lieu of a regular flotilla meeting. FSO reports/7029 forms were submitted prior to 15 DEC 2019, so that credit would be received in 2019. Over 8900 hours were reported for the flotilla in 2019.

*PA Events*: Aux. Moore and Aux. Shabaaz participated in a program for Veteran's Day, at Blue Skies of Texas-West, and represented the USCGAux. Aux. Shabaaz read the names of 35 residents (both retired military and civilians) that died in 2019.

Shabaaz attended the funeral services for an Unaccompanied Veteran, SP4 Ronnie Dutton, (1948-2019). SP4 Dutton served in the U.S. Army from 1968-1970. The service was held at Fort Sam Houston National Cemetery, on 08 JAN 2020. The three Flotilla 7-4 members represented the USCGAux and wore the dress blue uniforms. Five Sea Scouts also attended the service including their Adult Leader, Mary Oakes.

USCG Auxiliary Division 7, D8CR – Meeting will be held 17-19 JAN 2020 in Corpus Christi. Boat Crew Training will be offered (Navigation class & and dockside PQS signoffs). TCT is required annually for all FSOs. Send RSVPs to Jeff Hughes for the Division Meeting. Meeting Registration form, Texas Hotel Occupancy Tax Exemption Certificate, Map, Auxiliary – Record of Unit Meeting, and Flotilla 7-4 Staff Officer Monthly Report Form were also distributed.

More state qualified instructors are needed for the San Antonio Boat Show in March. Consider taking the course to become an instructor.

Flotilla members were encouraged to attend Sea Scout meetings on Thursday, when possible, in Cibolo. Some of the history of the Sea Scouts was discussed. There is also a Sea Scout Troop in Boerne and Canyon Lake. All three may participate in the Boat Show next year, 2021.

All members were encouraged to take the Boy Scouts, Youth Protection Training. The course is on-line at <a href="https://www.my.scouting.com">www.my.scouting.com</a>. The certificate is good for two years.

The next Division 7 meeting will be 17-19 April 2020 at Sector HQ, Corpus Christi.

There will be a District Meeting 19<sup>th</sup> – 22nd March, in Houston, TX at South Shore Resort & Spa.

The San Antonio Boat Show will be held 27-29 MAR 2020, at the Freeman Coliseum. Most classes will be taught on Saturday and Sunday. The uniform of the day (UOD) will be Trops.

SEPTRAIN will be held 10-13 OCT 2020, in New Orleans, LA.

There will be a uniform inspection at the February Flotilla 7-4 meeting. All Flotilla 7-4 members (men and women) should wear a V-neck undershirt under the shirt/blouse. There was a review of the belt buckles and directions of the belt when wearing male & female belts. All members were encouraged to review proper wearing of the USCGAux uniforms.

Information about C-Schools was shared with the members. The classes are usually held during the week. The AUXLAM course is one weeklong. Part A or B can be taken in any sequence (A or B first). A physical inventory will be conducted following the meeting today.

FSO-FN/IS: Gawron Rosario reported that the Flotilla is losing money monthly at the current bank. She made a motion to change to a different bank where there is no minimum balance. The motion was seconded by member Shabaaz. The members agreed to change the bank. FSO-FN/IS: Gawron Rosario will complete the necessary paperwork (form 7025) to close the current account and open a new account with Wells Fargo Bank.

FSOs were encouraged to submit a budget at the next meeting.

A committee was formed to conduct a financial audit following the Flotilla meeting (Aux. Ansbergs, Puharic & Moore). The results of the Financial Audit will be reported at the next meeting.

There was discussion about food/snacks, coffee and water for the meetings. For the past two years W. Moore, A. Shabaaz & J. McNamara provided food for meetings. B. Rosario and D. Gawron-Rosario paid for coffee for the group during 2019. It was suggested that members donate food and/or snacks when they can. All members can get free coffee, at BST-W, on the 1st floor and bring it to the meeting on the lower level.
