Congratulations Charles! Charles has outlined some goals for 2025:

1.) Recruitment

One of the primary goals for 2025 is recruitment. We are down considerably from where we were a few years ago. Part of this is because people have moved, part of this is still related to recovering from the pandemic, part of this has to do with the status of the lakes, and part of it is just economics. \$80 is a lot of money right now regardless of your financial situation. We need to start getting more involved in public affairs within the community. whether it be parades, hobby shows, university outreach, etc. We also need to work on our social media and online presence, this will help too. These are some of the ways to get more people and we will discuss those in more detail as time moves forward.

2.) Public education / Vessel safety

Our primary way of helping people in our community is through our knowledge on and off the water. We currently have one place to do training events @ REI off Huebner Oaks. I would like to expand that especially as the boating license is now starting to become a requirement (finally) in the state of Texas for those born after 1993. I would also like to continue building on our vessel safety examinations even though the lake is down. We need to go by the local marinas and let them know that we can inspect vessels when they are on their trailer. They don't have to be in the water to be inspected. Also, we need a FSO-PV if you know someone that would be willing to step into that role.

3.) Culinary arts program

We are fortunate enough to have the SO-CA in our Flotilla. I want to take advantage of that.

This really ties back into #1 but this is a great way for individuals that may not have been eligible to join the Coast Guard (that are eligible for the Auxiliary) and for people that are veterans but still want a way to be a part of the service. You do not have to be a chef to be a part of the Culinary program. Most of your training is OTJ.

4.) Administrative assistance for CG

We have several roles in the Coast Guard Active Duty that they are constantly looking for assistance with. From watchstanding to marine safety, I really want to focus on how we can help Sector. We have the DCDR in our flotilla, that's another part I want to take advantage of. Utilize the knowledge given to us from Division and build the support that the CG asks us for. Our motto is "Semper Paratus", I want to show Sector we really are always ready.

5.) Fourth Cornerstone

We have to remember that we are a volunteer unit. Yes, our primary responsibility is to assist the Coast Guard and our community. However, if you want a volunteer organization to thrive, you also have to cater to the member. I want to establish a 4th cornerstone (Fellowship) piece within the Flotilla. Coast Guard adds first polar icebreaker to its fleet in 25 years, By Kathy Murray, Senior Writer, MyCG

12/23/24. The Coast Guard has officially welcomed its first polar icebreaker in more than 25 years – the recently acquired Aiviq, a commercial vessel that will be renamed CGC Storis.

Storis means "great ice" in Scandinavian. The name is also a nod to the original CGC Storis, a legendary light icebreaker and medium endurance cutter commissioned in 1942 that patrolled for submarines and ran convoys during World War II and led the first American transit of the Northwest Passage. In 1948, Storis was moved to Alaska where it conducted law enforcement, search and rescue, and humanitarian relief for 59 years until its decommissioning in 2007. The new CGC Storis has undergone limited changes since its acquisition last month. These included painting the hull red and labeling the ship as WAGB-21. The vessel will be permanently homeported in Juneau, Alaska once the shoreside infrastructure is ready. The design and construction work for the homeporting project will take several years.

"The Coast Guard is thrilled to acquire this icebreaker," said Commandant Adm. Linda Fagan. "Like its namesake, this cutter highlights the Coast Guard's long history of operating in the Arctic and demonstrates our commitment to assert and protect U.S. sovereignty in the region."



How it came about

The Coast Guard received appropriation for a commercially available polar icebreaker in 2024 to supplement mission readiness and capability in the polar regions while Polar Security Cutters (PSC) are built. At a time of heightened activity in the area – including the first joint Russian/Chinese patrol passing near Alaska this summer – the Service only has two operational polar icebreakers. Our medium polar icebreaker, CGC Healy, was temporarily sidelined after experiencing an electrical fire in July. Meanwhile, the CGC Polar Star, a heavy polar icebreaker, is nearly 50 years old.

On Nov. 20, the Coast Guard purchased the M/V Aiviq, a 360-foot U.S.-built polar class 3-equivalent icebreaker for \$125 million in a deal with Offshore Surface Vessels LLC. The vessel, which was constructed in 2012, has supported oil exploration in the Chukchi Sea off

the coast of Alaska in the Arctic Ocean, and has deployed twice to the Antarctic. As a polar class 3-equivalent icebreaker, the future CGC Storis is expected to be capable of operating in waters that are otherwise inaccessible to most Coast Guard cutters.

What this means for future icebreakers

Buying the future CGC Storis won't affect the acquisition of the PSCs. The Coast Guard still needs a mix of eight to nine polar icebreakers to meet its operational requirements. In a congressional hearing last month, Vice Adm. Peter Gautier, the Deputy Commandant for Operations, noted the challenges in the region were mounting. "I acknowledge we have a national security threat now from the increased threat of competitors who are working together in ways we have not seen," he said, adding that the U.S. would be at risk without these new icebreakers.

The Coast Guard is authorizing the shipbuilder, Bollinger Mississippi Shipbuilding, to build the first 16 modules that will be incorporated in the first PSC, CGC Polar Sentinel, with estimated delivery in 2030.

In the interim, the future CGC Storis is expected to help bridge the gap and provide additional capability in support of national security in the region.

How was the new icebreaker named?

Before the future CGC Storis was acquired, a working group generated a list five potential names that were submitted to an official naming committee composed of senior officers and enlisted personnel. This group ranked their top three choices.

"Storis" was an early favorite given the long history and accomplishments of its namesake. In addition to its previously mentioned activities, the original CGC Storis:

 was first to arrive to the scene of the sinking CGC Escanaba in 1943, which was believed to have been torpedoed or hit a mine

- became the first U.S. registered vessel
 to circumnavigate North America
- was on scene for the largest U.S. earthquake (magnitude 9.2) in Alaska in 1964
- was the oldest commissioned cutter in the Coast Guard during its tenure, earning the title "Queen of the Fleet"
- participated in the 1990 rescue of the M/V Alaskan Monarch off of St. Paul Island, which was immortalized in the movie, "The Guardian"

How big will the crew be on this new icebreaker?

The initial commissioning crew of the future CGC Storis will consist of approximately 60 officers and enlisted personnel. They will be assigned in the summer of 2025.

COAST GUARD SAVE LIVES!

Coast Guard rescues 4 from sinking vessel Press Release, Jan. 5, 2025

MIAMI - A Coast Guard Station Marathon boat crew rescued four people, Sunday, after their

27-foot vessel began taking on water approximately 11 miles north of Marathon, Florida. No injuries were reported.

Coast Guard Sector Key West watchstanders received a distress call around 5 p.m. of a vessel taking on water. Coast Guard Sector Key West watchstanders launched a Station Marathon boat crew who arrived on scene and embarked four individuals.

All four were taken ashore at the 33rd Street boat ramp.

"Our crews consistently prepare to respond to these situations day and night" said Petty Officer 3rd Class Zachary Aparo, a Sector Key West watchstander, "Thanks to their prompt call for help, we were able to get on scene quickly and conduct a successful rescue before they entered the water."

Boating Safety - "Boaters should remain vigilant on the water as most incidents occur when you might least expect them – in good visibility, calm waters and little wind," said Capt. Amy Beach, Inspections and Compliance director. "The most frequent events involve collisions with other vessels, objects or groundings, which is why it is so important to keep a proper lookout, navigate at a safe speed, adhere to navigation rules and obey navigation aids." Deaths occurred predominantly on vessels operated by individuals who had not received boating safety instruction, accounting for 75 percent of fatalities. Drowning accounted for 75 percent of deaths, with 87 percent of those victims not wearing life jackets. The Coast Guard reminds boaters to wear serviceable, properly sized and correctly fastened life jackets. In addition to wearing a life jacket and taking a boating safety course, the Coast Guard recommends all boaters attach the engine cut-off switch, get a free vessel safety check and boat sober.
