Unless you opt out of the Arbitration Provision section within 60 days: (1) you will only be permitted to pursue claims or disputes and seek relief against us through binding, final arbitration, with limited exceptions, and you waive your right to participate in a class action lawsuit or other representative proceeding or class-wide arbitration; and (2) you are waiving your right to pursue claims or disputes and seek relief in a court of law and to have a jury trial.
