ARTICLE IV- MEETINGS

4.1 The Flotilla shall hold a regular meeting each month on the third Monday at 1930 hours at the Omaha Tangier Shrine, 2823 S 84th St, Omaha, NE 68124.

.ARTICLE VIII - FINANCES

8.1. The annual Flotilla dues shall be \$8.50, (this does not include the additional annual dues which are set for Division and District and could change due to Division or District policy) or such sum of money as may be fixed by a majority vote at a regular or special meeting of the Flotilla, at which seven (7) days prior written notice of the meeting and intent were given, and shall remain fixed at such sum in ensuing years until otherwise duly changed by the Flotilla. However, any such vote in the amount of dues shall be made at least four months prior to the effective date of such change.

8.2. A notice shall be sent to each member on August first and a second notice on September first to members who have not paid their dues. If a member has failed to pay their dues by October first, either the Flotilla Human Resources Officer or the Flotilla Commander shall contact them. If satisfactory arrangements are not made with the Flotilla, and dues are not paid by October fifteenth, a Change of Membership Status Form will be sent to the member(s) by the Flotilla Commander. The names of members who have not paid their dues shall be submitted to DIRAUX on November 15th with a recommendation that they be dis-enrolled from the Auxiliary for non-payment of dues.

8.8. A floral arrangement, memorial to a charity, or monetary donation, may be purchased by the Flotilla for the purpose of funeral or illness to the following persons and active members of the Coast Guard Auxiliary. This may be done for members of Flotilla 33-1 and their spouses, currently serving Flotilla Commanders of Division 33, currently serving Division Commander and Division Vice-Commander of Division 33, the currently serving Commodore, Chief of Staff, and District Captain who are members of a Division 33 Flotilla, and Past Commodores who are members of a Division 33 Flotilla. The cost of such floral arrangement/memorial to a charity or monetary donation shall not exceed \$85.00 (eighty-five dollars).

A sympathy card may be sent to the appropriate person upon the death of an immediate family member or relative of an Auxiliary member of Flotilla 33-01. A sympathy card may also be sent upon the death of another person as deemed appropriate.

The incoming Flotilla Commander shall be reimbursed up to \$60.00 for a gift for the retiring Flotilla Commander who has currently served one full year or more in that office, in token of appreciation for that Officers service to the Flotilla.

ARTICLE X1V - APPENDICES

14.1 These Appendix to The Standing Rules may be amended at any regular or special meeting of the Flotilla, at which fourteen (14) days prior notice of the meeting and proposed amendment was given, by an affirmative vote of two-thirds (2/3) of the members present.
