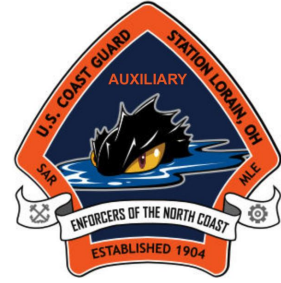

- *GOOD NEWS: The Ohio Lake Erie Commission and The Ohio EPA are planning to recommend to the US EPA that the Black River "Beneficial Use Impairment" (BUI) regarding the health of fish in the waterway should be removed. The river has been one of 25 Areas Of Concern (AOC) in the Great Lakes since 1987. The fish tumors and lesions were a result and indicator of toxic chemicals in the water. There are still four of the original nine BUIs before the Black river can be delisted as an AOC.
