FLOTILLA COMMANDER REPORT - Bill Ferry

 May was a very busy month for Flotilla 092-06-04. As we head into the Operations season, also known as the soft-water season, the pace of activities is quickening.

- May saw the end of Station Checks at Station Lorain, and a welcoming back of the Active-Duty Coast Guard.
- FSO-VE Russ Cromwell put together a Division-wide training session on current and best practices in Vessel Examination, and held a repeat session for those who could not attend the first. This training comes just in time for the Vessel Examination busy season, which is generally May and June.
- Boat Crew Members continued with the regular monthly training provided District-wide by Commodore Lauer and his crew of trainers.
- The Boat Crew, under Coxswain Jack Benton, continued maintenance and upgrade work on AUX 64, the Flotilla's Facility boat.
- At the end of the month, National Safe Boating Week was held 20 May through 26 May. In conjunction with this event, our Flotilla engaged in the following activities:
 - 1). A Vessel Examination outreach event at the Bay Boat Club, Bay Village, Ohio on Saturday the 20th; and
 - 2). An AuxPad Ashore outreach event at the Bay Village Senior Center on Tuesday the 23rd; and
 - 3). A Vessel Examination outreach event at the Lorain Harbor Boat Club, Lorain, Ohio, on Saturday the 27th.
- Importantly, the above Vessel Examination outreach events look like they
 will be a permanent addition to our Flotilla schedule. This is based on the
 excellent relationships forged between Flotilla and Boat Club personnel.

- The items gathered are more of an interest then flotilla/division activities news.

- I have few pictures but members not in uniform (work party type events) so using them would be in question.
- Time I have available is a big issue. Too many auxiliary duties and PB ends up being low priority to the other auxiliary jobs.

- During May, the Flotilla organized an AuxPad Ashore Public Education outreach event. This was the talk about kayaking and paddle craft safety to the Bay Village Senior Center's "BV60+" group, which is for active seniors. Members Jeff Burdick and Bill Ferry joined two representatives from the American Canoe Association (ACA) to share safety information.
- At the event, Members Burdick and Ferry brought their own kayaks, as examples of a well-outfitted fishing kayak and a basically-outfitted recreational kayak, respectively. Between the USCG Aux and the ACA, we had two tables of various kayaking safety and convenience gear, and a table of literature and take-homes, including free PFD Whistles, Paddle Reflective Stickers, and IF FOUND stickers for paddle craft.
- Approximately 15 to 20 persons were in attendance, including a City Councilperson at Large.

- Workshop "Getting on the same page" was offered on line on two dates, 5/17/2023 and 5/25/2023. Around 50Feed back for the workshop has been very good.
- 50% of flotilla VE's/PV's attended our online workshop. (was same percentage for division)
- 2 flotilla members attended the workshop when it was offered the 2nd time.
- 4 flotilla members attended the workshop even though they were neither a VE or a PV!

- Requested at division meetings that VE's send copies of all VE forms sent in or entered into Auxdata II to the SO-VE for data gathering and the SO-IS for verifying data entry.
- We found out one flotilla member needed to turn in the 2003 VE workshop.
 As soon as he was notified it was done and it is now in Auxdata II that he did it. Our flotilla now has the 2023 VE workshop done for all members.
- Received revised new VE and REYR Certificates of Compliance from Glen Harman DSO-VE 9ER. A new requirement mentioned is the need of an "Activity Log Number" in reference to the training of a new VE or someone from REYR. If you do not have access to the Activity Log Number, request assistance from your FSO-IS staff officer. Thanks Glen for the updated information!
