USCG News:

2018 Recreational Boating Statistics (Abridged):

The U.S. Coast Guard released its 2018 Recreational Boating Statistics Report Tuesday, revealing that there were 633 boating fatalities nationwide in 2018, a 3.8 percent decrease from 2017.

Alcohol continued to be the leading known contributing factor in fatal boating accidents in 2018, accounting for 100 deaths, or 19 percent of total fatalities.

Half of a boating party perished in Alabama in July 2018 when an inebriated passenger bumped into the operator, who had also been drinking, which caused the operator to swerve and crash into a bridge piling at about 25 mph. Two people were killed, including one who was struck by the boat's propeller. The operator had a blood alcohol concentration level of 0.15, nearly twice the state's legal limit of 0.08.

Operator inattention, improper lookout, operator inexperience, machinery failure, and excessive speed ranked as the top five primary contributing factors in accidents.

Where the cause of death was known, 77 percent of fatal boating accident victims drowned. Of those drowning victims with reported life jacket usage, 84 percent were not wearing a life jacket.

Where boating instruction was known, 74 percent of deaths occurred on vessels where the operator had not received boating safety instruction

The most common vessel types involved in reported accidents were open motorboats, personal watercraft, and cabin motorboats. Where vessel type was known, the vessel types with the highest percentage of deaths were open motorboats (50 percent), kayaks (13.5 percent), and canoes (7 percent)

Auxiliary Mishap Investigation Results:

Ninth District Auxiliary,

On June 29th, an Auxiliary vessel mishap occurred during a patrol while on Coast Guard orders for a marine event in the Ninth District. The vessel with six Auxiliarists onboard allided with a bridge while traveling to the patrol location. Fortunately, no one was injured. As a result, an investigation was initiated and recently completed. The investigation determined the Coxswain of the vessel was intoxicated at the time of the bridge allision and subsequently blew a .262 BAC and was issued Federal tickets for boating under the influence and negligent operations. Additionally, the investigation showed that two of the crewmembers onboard the vessel were aware the Coxswain was intoxicated and indicated that this was a "normal occurrence" over the past several years. The crewmembers failed to take action to prevent the Coxswain from operating the vessel or report his intoxication. As a result, I have disenrolled the Coxswain and two crewmembers from the Auxiliary.

It baffles me that this incident was ever allowed to occur. I know that you too are extremely disappointed in the actions of a few members of our team. This should be a wakeup call for all of us to re-examine our cultural norms, how we operate, and apply our Service's Core Values.

Again, I would like to stress to our Auxiliary crews the importance of applying Team Coordination Training during all aspects of Auxiliary operations. It is imperative to strictly follow the Risk Management cyclical process of Identifying Hazards, Accessing Hazards, Developing Controls and Making Decisions, Implementing Controls, and Supervising/Evaluating. Determining the level of risk against the probability of a mishap occurrence for an identified hazard and being assertive to take the corrective action required is vital for safely completing a mission. Performing these functions are critical when assigned to duty and goes to the heart of our Core Values of Honor, Respect, and Devotion Duty.

Please do not think the inappropriate actions of a few members takes anything away from the outstanding reputation of the Great Lakes Auxiliary. I am extremely proud of the Auxiliary and the tremendous work you all do. Thank you for your dedicated service to the Coast Guard and our Nation.
