**MS (Marine Safety), SO Jay Katzman:** Participated in the Blessing of the Fleet that was held at Navy Pier on May 22nd. In honor of Memorial Day, MSU Chicago staff and volunteers from the U.S. Coast Guard Auxiliary marched in the Chicago Memorial Day Parade. Dignitaries included veteran and Senator Tammy Duckworth, Mayor of Chicago Lori Lightfoot, Brigadier General Kris Belanger of the 85th Support Command, with U.S. Army Reserve Major General Marion Garcia serving as Grand Marshall of the parade.

Starting June 1, Starved Rock and Marseilles locks on the Illinois Waterway will be closed to commercial and recreational traffic from 6 a.m. to 6 p.m. to prepare for upcoming major maintenance. The 12-hour closures will take place daily from June 1 to July 3 and from July 8 to Aug. 16. Both locks will be open for normal, 24-hour operation July 3-7 to clear any backlog of traffic and accommodate for increased recreational boating during the Independence Day holiday.

The Illinois Department of Natural Resources has closed access to the Fox River to recreational vessels between Stratton Lock and Dam south to the Bridge Street Bridge, in Lake, McHenry, Kane and Kendall Counties, due to hazardous conditions including swift current, floating debris, and submerged objects. Estimated duration of the closure is undetermined at this time.

#### **Flotilla 39 (06) FSO-MT Report for May**

##### **Topic 1: Common training to establish qualifications**

Last year we performed the classroom portion of vessel examination training, and the season closed in on us before we were able to complete the training. This spring we will take those members who still need to perform their five VSC's under supervision and complete that task. This should begin next week.

With respect to boat crew training, except for the signoff's, all of the dockside instruction has been completed. We continue to finish off the details so that all of the members can move forward and get the dockside signoff's completed so that they can get their gear issued to them and thereby be able to begin their underway task instruction and signoff's. Before the summer is over, we hope to have all students on the water and making significant progress toward completing this qualification.

Along these same lines, we have two members who are slowly making progress toward completing coxswain training. At least one of them should be able to finish this qualification before fall.

Another category of training is REYR. Flotilla members qualified in either crew and coxswain categories are included in the summation. One member has returned his PPE gear to the OTO's office.

##### **Topic 2: Reduction of Flotilla 39 (06) Members in AP or IQ Status**

AP Status: one flotilla member in 56 is still in AP status. This is 1.8% of flotilla membership as opposed to a district-wide fraction of 9.6%.

IQ Status: two flotilla members in 56 still in IQ status. This is 3.6% of flotilla membership as opposed to a district-wide fraction of 2.9%.

The monthly goal will be to reduce the number in each category by one until the flotilla reaches zero in each category. This will be achieved of monitoring the member's performance and having periodic meetings with the member as well as the mentor assigned to the member.

It looks like 095-39 has been assigned 26 of them but the paperwork sent is of poor quality and I will need to clarify exactly what bridges we have been assigned. Fortunately, there is no time limit restrictions but they are expected to be completed this season. **Correction:** The additional Class I PATON, mentioned in the 39-08-NS report, that originally was assigned to 39-08-AV Ronald Dzaigwa, because it was near the location of another Class I PATON originally chosen by him, was completed and recorded 30MAY2019 by 39-06-AV Michael Raith.
