

AUXDATA II will shut down on 20 September 2025 as outlined in ALAUX 032/25. Leadership is currently engaged in actions to maintain program availability, but we need to prepare for the system to go offline for at least three weeks. I am not

aware of a record export feature, so you'll have to manually copy all of your data.

#### Recommended actions:

Individual Members: Back up your data by creating print screens of your Detail, Related, Skills and Availability, and PPE pages. Be sure to capture Member Status History, Member Activities, Competencies, Member Tasks, Awards, Member Offices, and Patrol history. Catch up on all of your hour logs now!

Flotilla Commanders:

Recommend you run and save all of your regular monthly report. Run a complete member roster as well. If you do not have an FSO for a particular office, run that FSO report data and maintain it on file.

Flotilla Staff Officers: Run the current version of your reports and keep them on local file.

## HONOR FLIGHTS



We still need Auxiliarists from Western Washington to help provide assistance and honor the veterans participating in four <u>Puget Sound Honor Flights</u> out of SEATAC Airport in 2025. The number of veterans traveling on each flight is increasing significantly this year, so we need more Auxiliary and active duty and reservist volunteers to help.

The USO provides a lounge for us to wait if there is down time, particularly on the Monday evenings as we are waiting for the veterans to return.

They also provide us with parking vouchers for the SEATAC parking garage. They request that we park on garage floors 1-3 or 5-8 and that we consider carpooling as much as possible.

Update for fall 2025: Saturday morning "send off" volunteers:

Departure Saturday, September 13, 2025: Alaska Airlines Flight #378 at 1010 hours. Veteran check-in begins at 0715. Auxiliary volunteers will need to arrive no later than 0645 at Alaska Airlines ticketing in the main terminal, near door #29. You will be given a gate pass by Alaska Airlines, so make sure you bring your government issued ID!

Departure Saturday, October 11, 2025: Alaska Airlines Flight #378 at 0908 hours. Veteran check-in begins at 0615. Auxiliary volunteers will need to arrive no later than 0545 at Alaska

Airlines ticketing in the main terminal, near door #29. You will be given a gate pass by Alaska Airlines, so make sure you bring your government issued ID!

### What to expect Saturday morning:

Auxiliary volunteers greet veterans as they arrive, assist them unloading their luggage as they get dropped off, help them get into a wheelchair if they would like one, provide them with a bag of swag and then escort the vets out to the gate. While they wait for their flight, there's plenty of time to chat with the vets, hear their stories and thank them for their service.

Once the vets have boarded the plane, those Auxiliarists who have a combination cover are escorted by TSA out to the tarmac to "man the rails," and render a salute to the vets on the plane as it backs out of the gate. Once the flight leaves, volunteers go to the USO to get parking validation before going back to the parking garage.

**UPDATE for fall 2025:** Uniform for the send off volunteers on Saturday mornings for the fall honor flights will be **trops** with a combination cover.

Monday, October 13, 2025: Alaska Airlines Flight #379 arrives at 2100 hours. Military and Auxiliary volunteers checkin with Alaska Airlines for gate passes at 1930 hours.

Make sure you bring your government issued ID! Alaska Airlines will give you a gate pass. At that point they usually ask the volunteers to wait up in the USO lounge on the mezzanine level until the TSA agents arrive to escort the group through security and out to the gate.

Uniformed personnel from all branches of the military (including the Auxiliary volunteers) walk in formation from Security out to the gate. Then there's a little more waiting until we line up to salute and escort the veterans as they disembark the plane one by one. Volunteers either push the vets' wheelchairs or walk alongside them as they walk through the airport to a reception in the main terminal where they meet their relatives and pick up their luggage. This is a great opportunity to chat with the veterans and ask them about their experience over the weekend, etc.

Once you have helped escort the veterans to the reception, you will go back to the USO to get your parking validation before leaving the airport. Note that the

Puget Sound Honor Flight staff are there to make sure everything runs smoothly! Also note, the time we depart the airport is approximate. Sometimes the flights are delayed. Please plan to stay until we have finished escorting the vets to the main terminal.

Uniform for Monday night "welcome back" volunteers is a complete and correct service dress blue bravo uniform with combination cover.

# USCGC EAGLE: HISTORY & SEATTLE VISIT

It was a cool, overcast morning as our facility made its way to Elliot Bay. I was stationed as the forward lookout, and for the first hour, there was very little boating traffic to report—mostly ferries crossing channels and a few fishing boats. However, once we entered Elliot Bay, we all spotted a white-hulled sailing vessel anchored in the distance. The vessel seemed completely out of place—a three-masted sailing ship against the backdrop of a modern city. This vessel was the *USCGC Eagle*.

The *USCGC Eagle* is a three-masted barque used as a training vessel by the United States Coast Guard Academy. Here are some brief statistics about the *Eagle*:

Length: 295 ft

Crew: 55 (working crew); 239 (maximum) Speed: 17 knots under sail; 10 knots under diesel engine

The USCGC Eagle began its life as the training ship Horst Wessel in the Kriegsmarine (the German navy between pre-WWII and during WWII). Commissioned in 1936, it conducted various training voyages around the Baltic and Atlantic from 1936 to 1939. During WWII, the Horst Wessel continued training cadets and managed to survive the conflict undamaged. After the war, it was turned over to the United States as war reparations and, in 1946, was commissioned into the U.S. Coast Guard Fleet as the USCGC Eagle. That same year, the USCGC Eagle departed Germany and arrived in New London, CT, its new home. Since then, the *Eagle* has trained Coast Guard cadets for the past 79 years. Notable missions over its service include many goodwill cruises, tall ship races, and fleet reviews.

This year, the *USCGC Eagle* conducted training and goodwill cruises along the Pacific West Coast. One of its planned ports of call was Seattle. As part of the escort into Seattle, the U.S. Coast Guard Auxiliary organized an escort flotilla that met the Eagle in Elliot Bay. This flotilla consisted of seven facilities from various flotillas throughout Puget Sound. I was fortunate to have the opportunity to participate in this mission, and alongside Bob Hamilton, I was aboard the John Edward's facility. We arrived early at the rendezvous point, which gave us a great opportunity to take close photos of the Eagle and observe how other auxiliary facilities arrived. The escort itself was quite straightforward, with the Eagle conducting two loop passes in Elliot Bay, flanked by auxiliary facilities on either side, before heading to dock at pier 66. It was a special sight to see such a beautiful vessel gracefully navigate Elliot Bay, a scene that must have been common 150 years ago in the same bay. The following day, I drove to Seattle to board the USCGC Eagle, which was open to the public for two days during its stay. Remembering the previous day and the few people I had seen on the docks watching the *Eagle*, I didn't anticipate a large crowd. To my surprise, when I arrived, there was a huge line that stretched across almost two blocks. After waiting for a while, I finally managed to get onboard. The first thing I noticed was

how tall the masts were and how much rigging surrounded us, it was quite a sight. I had the chance to talk to several cadets, all of whom shared stories about climbing those masts. As they said, "There is no better view than from the top of the mainmast!" Walking around the deck of the Eagle helped me appreciate our modern vessels while highlighting the skill required to crew and operate such a ship. I have no doubt that the cadets who sail the Eagle will leave with many great sea stories and experiences that will make them even better officers. It was a privilege to come aboard and assist in the escort mission, and it's an experience I will cherish for a long time!

# COMMERCIAL FISHING VESSEL EXAMINER

The Coast Guard is actively seeking Auxiliarists willing to serve as Commercial Fishing Vessesl Examiners. The District had four full-time inspectors – they are now down to zero. Details posted below:

### USCG Auxiliary Commercial Fishing Vessel Safety (CFVS) Examiner – Program Overview

Sector Puget Sound (SPS) is billeted for 5 full-time CFVS Examiner civilian employees (4 GS12s and 1 GS11). Through existing vacancies, resignations, retirements and transfers, all positions have been vacant since July, hence this urgent need.

SPS should be doing about 300 CFVS Dockside exams per year. While they do exams on very large fishing vessels, a significant number are done on vessels less than 65 ft (mostly tribal fishing vessels).

# The areas of greatest need are in the outlying areas:

- <u>Bellingham-Blaine</u> boat harbors are very busy in May/June.
- The Lummi Nation vessels call for exams ahead of fish openers-typically in February
- Anacortes/La Conner: Significant number of 58 ft purse seiners needing exams Apr-June; Swinomish tribe calls for exam ahead of fish openers

Port Angeles (PA): Occasional requests for exams in PA. FTE examiners have to travel from Seattle (takes entire day to do 1 vessel, because of the travel).

• **<u>Kitsap Peninsula:</u>** Primarily the Suquamish fleet near Brownsville.

#### Primary assistance needed is with:

- Exams of smaller fishing vessels in the outlying areas.
- Dock-walking and outreach with local fishermen-advertising our services, and distributing Information.
- Help with damage control trainer, stability model, etc. during safety fairs or training.

#### What are we looking for:

- · Aux members of good standing
- · Experienced Vessel Examiner
- · Good communication skills
- Positive representative of CG and CFVS Program.
- Good mobility for getting on/off vessels. Physical ability to move through a vessel, climbing ladders, etc.
- Ability to understand and decipher CG regulations, standards and policies. Being a CFVS Examiner is not for everyone.

# **Qualification Process - The CFVS PQS is a Gold Side (not AUX) PQS**

The qualification process requires dedicated work on the part of the candidate.

#### The candidate will need to:

- Receive an Assignment to Training Duties memo for Sector Puget Sound
- · Complete the CFVS Examiner Course on Moodle
- Complete a Gold Side PQS package that has been adapted for AUX members (44 tasks)
- Work with a Verifying Officer (VO) from SPS or NW District for sign-offs
- · Complete a Confined Space Entry Course
- Complete a Fishing Vessel Drill Conductor Course
- · Perform a Check-Ride with a Verifying Officer
- Stand an oral qualification board
- Receive a CFVS Examiner Qualification Letter

### After qualification:

- CFVS Examiner will perform duties for Sector Puget Sound Chief of Inspections, CFVS Branch Leader
- · Check-in, Check-out with CFVS Leader
- CFVS Exams are generated through member's dock-walking, outreach, and notifications from CFVS Leader
- Exam reports and vessel photos are emailed to CFVS Leader
- · Keep copies of paperwork/ reports.

· Report hours and exams through Auxdata II

Must complete 5 exams and 80 program hours annually to retain qualification.

#### Area of Responsibility (AOR)

- Most aux members do not receive travel reimbursement for their duties. But on occasion, will be asked to do activities outside their normal geographic area and will be placed on travel orders for reimbursement.
- Aux members will have a base geographic area based on a Flotilla or CG Station that will be considered their local commuting distance (no travel reimbursement). Activities outside this area may have reimbursement for travel—ONLY with prior authorization and the availability of funds.
- Special circumstances may involve TDY travel orders for overnight trips (lodging/per-diem/travel reimbursement).
