Recommendations:

- o All Directors should receive other Directorates Quarterly Reports, NEXCOM
- o comments in a timely manner.
- OPCOM Format possible change to be Roundtable discussions for 2 hours with two way communication and agenda items for discussion with larger group.
- Directors and ANACO report should be a short 2 minute report that is *forward looking* and not referenced to what was reported on Quarterly Report and forward up the COLM. NEXCOM Reporting to OPCOM on items from NEXCOM meetings that have impact to OPCOM.
- Condensed Quarterly Report version to be formatted as two column magazine style with pictures or illustrations and sent out to the membership on a quarterly basis on what program changes are occurring that would be of interest to the membership.
- o Director's Council should continue to meet both virtually and in-person to further

- o our collaboration, refine the missions and scope.
- o NTRAIN and NACON: 3 hours schedule time is requested for Directors Council.
- Virtual training should be developed and delivered on the Google Docs system to better utilize the technology and gain the most efficiency available.
- o Go to Meeting on a monthly/semimonthly basis with agenda being distributed in advance.
- Directors will appoint a leader for one year that will coordinate with other directors to lead, facilitate discussions and develop agenda for each meeting. DIR-S will pole the directorates to identify leader for 2015.
